V. Public Comment

A member of the public advised about statistics under previous directors and euthanasia rates. Requested TNR program.

A member of the public expressed concerned about adoptability with adoption by appointment system. Advised on euthanasia rates, requesting meetings be moved to evenings.

A member of the public expressed concern on euthanasia rates and the amount of time animals are networked prior to euthanasia. Concerned about adoptability if public cannot walk through kennels.

A member of the public expressed concern of shelter not being open. Expressed want for TNR program to help with over population and reduce bottle baby feeding needs.

A member of public expressed want for a robust volunteer program.

A member of the public expressed concern of shelter not being open. Expressed want for more large dog enrichment programs with trainers. Expand out of state rescue partnerships.

A member of the public expressed concern with adoption by appointment process. Expressed concern of record keeping and care of adopted animal.

A member of the public stated she started petition and inquired how many signatures will she need to open shelter. Inquiring how animal bios are visible, requesting director be present during meetings, questioned validity of appointment numbers.

A member of the public requested COT staff provides their section reports so they can answer questions. Requested information regarding where animals are transported to with rescue partners. Advised some rescues may be pulling less than previously. Requested more social media posting of available animals. Expressed concern on foster program. Requested director be present.

A member of the public expressed concern about public access to animals. Recommended having volunteer escorted visits. Expressed interest in having members of the public view small dog play group.

A member of the public submitted an email comment to express concern over euthanasia processes. Expressed need for more social media postings.

#### VI. Board Comments

Committee Member Kane expressed concern about fosters being on surgery schedule prior to return to the shelter.

Committee Member Josephson advised she will discuss spay/neuter protocol for fosters with director and assistant director.

Committee Member Kane inquired about temporary veterinarian staff.

Committee Member Kane inquired on putting all available animals in the same building.

Committee Member Kane advised on having handlers aware of signs of stress in dogs to eliminate stressors or remove dog from situation. Having volunteers or employees do escorted walk throughs to help mitigate having dogs put into harmful/stressful situations.

Committee Member Josephson advised that building 3 is set up to show case available dogs.

Committee Member Kane advised priority is to protect animals which may include not allowing public to walk through.

Committee Member Josephson advised she walks visitors through her rescue and advised OCAC on her processes with volunteers.

Chair Amundson inquired if data is available about how other large shelters facilitate volunteer programs.

Committee Member Kane advised concern for animal health and advised a middle ground needs to be found to mitigate the stress put on animals when visitors walk through.

Chair Amundson acknowledged progress over the past 6 to 8 months to progressively open the shelter and stated hopefully more efforts are made to return to a more normal process with volunteers.

Committee Member Josephson expressed concern with OCAC's current adoption processes. Advised about benefits of the shelter's facility layout. Recommended collaboration between OCAC upper management and the public. Shared opinion on OCAC Fact Checker document and provided comment on multiple sections.

### Public Education Program

The primary focus of our Public Education Outreach is to foster relationships with the areas we serve to effectively share valuable information regarding disaster preparedness, animal welfare, proper animal care, and responsible pet ownership. OC Animal Care recognizes the importance of providing essential resources to our community by attending events to provide information. We continue to enhance OC Animal Care's main website, Facebook, Twitter, and Instagram pages to make shelter announcements, promote education and adoption, community outreach, and animal safety.

### <u>Let's Paws</u>

We continued our bi-monthly Let's Paws campaign, helping educate the public on relevant animal-related pet safety tips. We posted timely information

### Pet Food Pantry

Our monthly Pet Food Pantry continues to be a vital community resource for pet owners in need. This quarter 66 volunteers contributed 404 hours to staging, directing traffic, giving great customer service to people in our community, taking stats, offering education opportunities, and handing out over 60,280 pounds of food to over 3,295 animals in need. We could never make this type of impact without this dedicated crew of people. The Pantry continues to grow bigger and bigger each month and the volunteer contribution is vital. In addition, to the Garden Grove students, we have collaborated with Marsh McLennan Agency, Cornerstone Treatment, and Home Team California in this past quarter.







### Foster Program

Animals are placed into foster homes for various reasons. They may be too young or too sick for adoption, they could be receiving treatment, or they need additional socialization. OC Animal Care's foster caretakers offer sanctuary for these animals in their homes, and provide around the clock care, comfort, and socialization until the pet is ready for adoption. They are specially selected by our veterinary staff for their health and temperament and just need a little personal attention and time before they are ready to make their adoption debut! The foster caretakers are a vital piece of the OC Animal Care family. This quarter, there has been a total of 797 animals in foster care. Our foster caretakers are saving lives!

### Program support

The Foster Program onboarded 3 new Foster Interns and an additional full time extra support for the very busy kitten season. The Foster Program received two additional incubators and foster kitten supplies to accommodate for this busy kitten seasons. The foster office and areas were painted and organized, which will create a more welcoming space for both our staff and volunteer caretakers!

In the month of August, the Foster Team had multiple influxes of kittens averaging about 29 underaged kittens per day. They were able to find placement (foster or guardian or rescue) for all kittens that were foster candidates.



In addition, we have been able to improve our pet's adoption profile pictures by taking pictures at the comfort of their homes and making our fosters apart of the pets' adoption process.







#### **Program Logistics**

The Foster Program has developed a Chameleon Report to indicate what kittens are due vaccines. Alongside, they have created email reminders that are sent out every two weeks for the health and safety of our foster pets.

The Foster Team has also been able to better fit fosters with kittens with our new Nursery Inventory Chart based on the maximum number of kittens our fosters can accommodate, if our fosters are comfortable with friendly, shy, or spicy kittens, and if our fosters are comfortable or not giving medication.

#### Volunteer Program

This report summarizes this quarter's activities for OC Animal Care's Volunteer Program and includes contribution hours, program enhancements/ opportunities, and volunteer participation. Volunteers contributed to exercising, grooming, handling, training/ socializing, and enriching available animals, as well as cleaning, laundry, socializing kittens in the nursery, and volunteering at our monthly Pet Food Pantry. This quarter 131 volunteers have provided 2,935 hours at the shelter.

#### New Volunteers

This past quarter we have ramped up onboarding new volunteers. We began slowly, hand picking a select group, and moved on to full-fledged recruitment efforts. We have welcomed 40 new volunteers with many more in process and are excited about our new group of animal lovers!

#### Pack Walk

Pack walks have ramped up our adoptions! In July, we decided to incorporate a "Meet and Greet" into our walks and invited the public to meet our pooches at our halfway resting point behind the Mess Hall in a beautiful park. We have had lots of visitors join us to walk back to the shelter to adopt. Due in part to the high exposure on social media of our pack walk dogs, 26 of the 37 dogs from this quarter's walks have found their forever homes. In August, we even added a bonus Pack Walk in addition to our regular one. We had an all-Husky walk called Husky Mush. We will be adding more breed specific Pack Walks in the future







### Volunteer Coffee

Our volunteer coffee is a great way for volunteers and department managers to connect. This quarter's special guests included: Our Customer Service team manager, Enrique Moreno, supervisors Amy Hernandez, and Pablo Acosta. Manager Link and Lt. Moon gave a great presentation about Field Services. We will have them again, the information they provide was very valuable. Last month, our Shelter Director Andi Bernard, attend our coffee, and answered a lot of question our volunteers had. We will continue hosting our monthly coffee chats.

They are long-time professionals who had their own grooming business for 30 years. They logged 28 hours just in September and are still going strong. This has been a HUGE help, not only with making dogs presentable and clean for events and adoptions, but also in helping our dogs who need medicated baths.





### Adoption Partners Program

Through cooperative actions, the Adoption Partner Program seeks placement for animals which need rehabilitation or additional support to be successful in their forever home. This report also reviews steps being taken to increase and improve adoptions and communication between OC Animal Care and Adoption Partners.

### Transports/Multiple Pet Adoptions

In July we worked with the Greater Good Foundation to transport a large group of kittens by plane to multiple rescue groups in Washington. We thank our staff, volunteers, and the Noble Friends Foundation for OC Animal Care for getting everything ready in advance and delivering the kittens to the airport. We thank the Greater Good Foundation for setting up the flight and inviting us to take part in this incredible effort to help our kittens find homes.

This quarter we also sent 13 dogs to a senior rescue in Oregon. With the help of staff and volunteers we were able set up multiple transports in July, August, and September. We are so happy to see our favorite seniors find placement.



In July, we took in a group of large hookbill birds as part of a case. We were able to provide them specialized veterinary care and eventually were able to place them with a rescue group that specialized in caring for birds of their type.







### Partner Adoptions

This quarter, 846 animals (142 dogs, 535 cats, 169 exotic/other animals) were placed with non-profit rescue groups, local veterinarians, or with partnered municipal and/or humane organizations.

#### Shelter Medical Pets Program

We continue to use the Shelter Medical Pets Program to help injured pets that come into OC Animal Care. We continue to reach out to veterinarians and welcome their interest in participating. This quarter nine pets received outside medical treatment, and the estimate for care for those pets was \$17,175.

With the help of the Noble Friends Foundation for OC Animal Care, private donations, and our wonderful participating surgeons who have given us generous discounts on surgeries, we have been able to help these pets get the specialized care they needed to increase their adoptability.

Reinstatement of the Trap, Neuter, and Return program for Feral cats at OCAC. The OCAC Tustin shelter was built with state-of-the-art facilities that planned for and included the only capacity for TNR in the county to operate this vital program. The cities and County taxpayers are paying for the facility with the intention to that this program would continue. Discontinuation has overwhelmed the streets with cats, causing many detrimental side effects, including spreading of diseases on the streets. It's a growing public health issue.

The reasons cited for not providing this service now are not valid, as the San Diego Humane Society lawsuit is strictly regarding friendly community cats, and the Cease and Desist Letter recently referenced in the press as a reason for stopping the program both specifically state that the parties want TNR to continue and expand, while discontinuing Return to Field of friendly cats that cannot fend for themselves only. In fact, Sharon Logan herself attended the July 2022 COC meeting and asked for reinstatement of TNR.

Moreover, the section of the penal code cited as creating potential liability for abandonment describes the conditions of feral cats as an exclusion to the definition of abandonment. Other counties throughout the state are operating TNR programs. If there is any validity to your claims that this is a controversial position, California case law needs to be brought to our discussion as every other cited reason is not accurate.

Finally, OCAC tells the public to return healthy, friendly cats who likely cannot fend for themselves to the streets, and regularly tell the public when they arrive onsite at the shelter to take the cats and dump them in the empty lots that are just offsite from the OCAC property—while promising that they will not prosecute them. This is 100% in opposition to OCAC's fears of potential liability for operating a TNR program. Besides, wouldn't OCAC be the agency referring any potential cases to the DA for prosecution. It would be simple to create a County policy position that this is not something subject to prosecution.
